This puppy is guaranteed to be a PET quality, healthy, active puppy when sold to the buyer. You have 72 hours to have this puppy examined by a licensed vet and if, for any reason, this puppy is unacceptable, buyer may return the puppy for a full refund, provided it is in the same condition as it was at the time of purchase. A written statement from the veterinarian must accompany the puppy stating the problem. This includes death or illness from any health condition deemed present prior to removal from seller's premises. The above puppy will be given adequate and proper care throughout its lifetime and all inoculations will be maintained to ensure preventative health care. **THE DOG MUST BE KEPT AS AN INSIDE DOG.** The puppy is not to become obese, allowed to run up and down flights of stairs, allowed to be on slippery surfaces for long periods, and should not be jogged, run or walked for extended lengths of time while growing as this can cause hip dysplasia. The puppy should be given proper shade, proper housing and properly and sufficiently fed. **THIS DOG SHALL NOT BE NEGLECTED OR MISTREATED IN ANY MANNER.** If seller becomes aware of any of the above conditions of neglect, it remains the right of the seller to reclaim the dog and issue no refund of monies.

**THE BUYER MUST RETURN THE DOG TO THE BREEDER IF THE DOG CANNOT BE KEPT AND IT CANNOT BE DISPOSED OF FOR ANY REASON. IT CANNOT CHANGE OWNERSHIP OR BE CO-OWNED AND MUST REMAIN WITH ORIGINAL OWNER UNLESS WRITTEN PERMISSION OF BREEDER IS GIVEN.** There will be NO return of money. If this is not done, court action will be taken and you will be fined \$5000.00 (five thousand dollars).

Reasonable precautions have been taken to prevent this puppy from acquiring hereditary faults. If the puppy becomes an UNFIT pet because of an hereditary problem during the first 26 months, seller agrees to replace the puppy with one of equal value, refund the purchase price or, in the event the buyer wishes to keep the puppy, will refund one half of the purchase price only if the buyer provides the seller with the following:

1. X-rays for submission to breeders vet for opinion or taken by breeders vet.
2. Proof of any hereditary defects, subject to expert opinion of breeders choice.
3. Proof of spaying or neutering by a qualified veterinarian.
4. No surgery on any problem is done without first consulting breeder and without consent of the breeder.
5. Unless the expense of surgery is required, and the dog is kept, no refund.
6. In the event of death, an autopsy must be performed to determine cause of death.

It is agreed that this dog will not be used for breeding purposes prior to 24 months of age and only with special permission of breeder. Prior to breeding, it must have documented clearances on hips, heart, eyes and elbows on both the stud dog and the female to be bred. ***If this is not adhered to, the breeder has the right to reclaim the dog and will not honor a guarantee for any reason and there will be no refund of money.***
